III. TREASURER'S REPORT

Michelle Martin Jones spoke about the impact of sending representatives to the National convention. Tamika Moss made a motion CPEA members sign to receive their ballots. Patricia Scheetz seconded the motion. There was no discussion. The motion passed. Sandy Rosetta suggested that next year those members that attended Rep Assembly should be able to give a brief talk about what was discussed at the RA.

Running for the 2 open ELT positions at High School for 2016-2018 are: Greg Soper and Cheryl Bissmyer and a nomination from the floor, Bryan Sheppard. Since three people are running for the two positions there will be an election for these positions.

Running for the 1 open ELT position at Multi-Level for 2016-2018 are: Patricia Scheetz and a nomination from the floor, April Chenault-McCleod. Since two people are running for the one position there will be an election for this position.
