A New Year-Are You Ready? By ECOEA President Angela Stewart

Welcome to 2015! January 1 brings renewed hope and new resolutions. I have never liked resolutions, maybe because like so many others, I rarely have been successful. To me they are promises made in January and then later broken and lamented about in late December. "I'm going to lose 20 pounds this coming year," becomes "Hey, I only gained 5 pounds this past year!" I've never understood why people wait until January 1 to identify and fix whatever problem they perceive to have. If you see a problem-no matter the date-fix it! If it isn't working, try a different approach. Isn't that what good educators do? And why don't resolutions work?! Maybe it's because we set ourselves up for failure. If we truly want our resolutions to work and as much as it sounds like writing learning objectives, they need to be clear, reasonable, and measurable. We need to have a plan and we need to have resources. Most importantly, we need to enlist the help of others to be successful. Besides making your personal resolutions this year, take a few minutes to make a few professional ones. I've been thinking about some changes I need to make since the OEA RA in December. President Higgins delivered a passionate, thought-provoking speech comparing our union to a tree. You can find the complete transcript at www.ohea.org. The analogy of a tree representing union membership was a visual one, eliciting some powerful reflections about our own Ohio Education Association, and ultimately our ten districts. Are our roots strong enough to withstand a "Right-to-Work" storm? Our union tree needs some tending and some TLC in order to grow tall with strong roots. We need to begin this new year with a resolution to engage our members more than ever. Relationships need to be built and strengthened if we want to have strong roots and substantial growth. It will take some time, but we need to start now. We cannot wait until the end of the year to determine if our resolution was successful or not. I can guarantee that our new body of legislators and appointees will not allow it! So let's work on some resolutions together! First, we need to be clear: OEA/ECOEA/Locals are not just officers and a few leaders. These organizations are EVERY member...YOU are OEA! No longer are unions just there to bargain a contract. Your union is fighting toxic testing, privatization, and many other issues that affect you and the learners you serve. Second, we need to be reasonable: We need to start engaging those members who haven't been participating. Relationships take time, but we need to start making some asks. We need more members to attend meetings and become more informed, to make contacts with legislators and other key figures, and to advocate for their association at all levels. Lastly, we need to measure our success: We need to be constantly communicating and checking in with those newly engaged members. We also need to expand our conversations with everyone we meet about why unions are important to them and especially the middle class. We need to stand up for ourselves and stop the flood of toxic rhetoric from the media. "Union membership is like a gym membership. Dues are paid to be part of a larger group with similar interests and goals. But, just like a gym membership-if you don't show up or participate, you do not become stronger. Unions are only as strong as their membership. Just like any neighborhood church, non-profit, or community organization-the respective strength rests with how many members of the group who actually stand and deliver." -unions4workers. If we are not going to exercise our rights, how will we become any stronger? How will our tree withstand the storm? We must be willing to stand up for ourselves and we must encourage others to stand up with us. Most importantly, we must start building relationships with all our members and with all those public education supporters. We need to be inclusive, not exclusive. Maya Angelou said, "I've learned that people will forget what you said, people will forget what you did, but people will never forget how you made them feel." So resolve to start having conversations now. Share your passion and your stories. Make someone feel valued and appreciated. Tend to your tree. For the storm is brewing...and we must be ready!
